Chief Wallace, Johnny Barnette, and Stephanie Collier are the only signatories approved for the accounts. Stephanie Collier has not been updated yet but was approved as a signatory in a previous board meeting. FIRE CHIEF J.T. WALLACE, JR.

## PARCEL FEE (DISCUSSION ONLY)

• Chief Turner informed the board that Mark from PMI resources suggested that BFD4 explore the possibility of a parcel fee in addition to the millage tax to increase revenue. Chief Turner stated that this was for discussion purposes only and nothing has been done to pursue this fee other than requesting the amount of parcels in the district. Chief Turner stated that obtaining a 35 to 55 dollar parcel fee could possibly generate an additional 6 to 8 hundred thousand dollars in revenue per year depending on the amount of parcels in the district. These funds would be used to hire more firefighters, replace equipment and apparatus, and possibly build a new station if needed as the district grows. Chief Turner stated that current funding will maintain what the district currently has but replacing equipment and apparatus will take longer without additional funding. Chief Turner informed the board that Mark would be at the next board meeting to discuss the parcel fee and could better answer any questions as he has helped several districts obtain a parcel fee.

#### CIVIL SERVICE/INTERNAL PERSONNEL ACTION FORMS

• Questions/Discussion about PA forms ---- Marvin Myers asked if the PA forms were the normal raises. Johnny Barnette informed the members that in a previous meeting it was approved to adopt pay scales and move all annual raises to the first pay check in January. The PA forms are for all employees and reflect those changes.

**MOTION** was made by <u>MARVIN MYERS</u> and seconded by <u>STEPHANIE COLLIER</u> to approve, and for the chairman to sign all Civil Service/Internal PA forms. The Chairman called for public comment; there being none, vote was taken and the motion carried unanimously.
